First class—Letters, written and sealed matter for local delivery or otherwise . . . per oz. 3c

Air mail—Anywhere U. S. Domestic Mail Service is in operation . . . per oz. 6c (limit 8 ozs.)

Air Mail weighing more than 8 ozs. subject to zone rates and conditions for Air Parcel Post Service. Air Mail Post Cards 4c

Second class—Newspapers, magazines and other periodicals, entered as second class matter, when mailed by the public, 1c for each 2 ozs. or fraction thereof, (or the fourth class rate, whichever is lower).

Third class—2c first 2 ozs. 1c each additional oz. Books (including catalogs) of 24 pages or more, seeds, cuttings, bulbs, roots and plants, 1½c for each 2 ounces.

Fourth class (Parcel Post)—Merchandise, printed matter, and all other mailable matter not in 1st, 2nd or 3rd class. Zone rates of postage apply. Consult nearest Post Office for rates.

Special handling—Fourth class matter only. Parcels of fourth class matter indorsed "Special Handling" will be given the most expeditious handling, transportation and delivery practicable (but not special delivery) upon payment, in addition to the regular postage, of the following charge: up to 2 lbs., 15c; over 2 lbs. up to 10 lbs., 20c; over 10 lbs., 25c.

Registered mail (postage extra)—25c to \$1.50, including indemnity of \$5 to \$1,000. Declaration of value must be made to P. O.—not on article. 5c fee charged for return receipt.

Special Delivery—First class, to 2 lbs., 15c; over 2 to 10 lbs., 25c; over 10 lbs., 35c.

Other classes—to 2 lbs., 25c; over 2 to 10 lbs., 35c; over 10 lbs., 45c.
